TYPES OF CHILD CARE

FAMILY DAY CARE

The largest percentage of children are cared for in family day care homes, especially infants and children under 3. In Pennsylvania, homes with more than three unrelated children follow state regulations.

GROUP DAY CARE

Group day care is child care provided in a home setting for 6 to 12 children. When there are more than six children present, two caregivers are necessary. Group homes are subject to many of the same regulations that govern centers and they must renew their license each year.

CENTER CARE

Child care centers accommodate groups of children, including infants, preschoolers and mixed ages. The number of children depends on the size of the center. Centers follow state mandated regulations.

The Central Intermediate Unit # 10 Preschool Early Intervention Program is a year round system that identifies and provides early intervention special education services to eligible young children who must meet the following criteria:

- * Ages three to five years old and not yet enrolled in kindergarten
- * Residing in Centre, Clearfield, or Clinton Counties
- * Exhibiting a developmental delay of at least 25% and/or a disability and in need of specially designed instruction.

The process of determining that a child has a developmental delay usually begins at the screening level. A multidisciplinary evaluation is conducted if the child does not pass the screening activities or there is supporting documentation that indicates the need to move directly to an evaluation. The family is the most important source of information and no assessment is conducted without the family's written consent. Programs and services for children who are eligible for early intervention are determined by a team of professionals and the child's family who develop a individualized education plan (IEP).

Preschool Early Intervention services for eligible young children are:

- * Provided at no cost to the family
- * Determined by the IEP team

Preschool Early Intervention services may include:

1. Home based Teacher and/or Therapists
2. Itinerant services provided by a Teacher and/or Therapists at a child's preschool, child care site, or Head Start
3. Classroom based services (both Integrated and Specialized classes are available)
4. Transportation
5. Teacher of the Hearing Impaired services
6. Teacher of the Visually Impaired services
7. Speech and Language Therapy services
8. Occupational Therapy services
9. Physical Therapy services
10. Psychological services
11. Assistive Technology services

Referral Process: Children may be referred by anyone involved in the child's life, however no further action will be taken until the family has been contacted and agrees to proceed with the referral.

The Lycoming-Clinton Early Intervention Program provides services for children ages birth to three who have a developmental delay of 25% or more in one or more of the five developmental areas, cognitive, communication, social-emotional, physical and adaptive skills and who live in Lycoming or Clinton County.

Referrals can be made by anyone who has a concern about a child's development. Services are provided at no cost to the family and are voluntary. A referral is made by calling one of the numbers listed above. A Service Coordinator meets with the family and coordinates assessment services. If a child is eligible an Individualized Family Service Plan is developed, a referral is made to a provider of Early Intervention services such as Infant Development Program and services start within 14 days.

Services include speech, occupational, and physical therapies as well as Special Instruction. For children with hearing or visual impairments EI also provides teachers who specialize in vision and hearing services. All services are provided in natural environments such as the family's home, Child Care or some other community setting.

What Keystone STARS means for YOU and Your CHILD

Keystone STARS is a quality rating system. It has four STAR levels as noted in the chart below. Each STAR designation has its own research-based performance standards. These standards measure three areas of child care that make a difference in the quality of care your child receives:

1) The staff employed 2) The environment your child is in every day 3) The way a facility runs their business

As a facility moves from STAR One to STAR Four, the requirements in these areas increase.

Below gives examples of the requirements each facility must meet at each STAR

level. In A One STAR Facility you will find:

- A DPW Child Care Certificate of Compliance/Registration for a year
- A plan to increase professional development and training for staff
- Increased staff communication by team meetings
- A completed self-assessment on quality items in the environment

In A Two STAR Facility you will find:

- Director and Staff must receive at least 3 to 6 hours more annual professional development and training than DPW regulations require
- The facility has a budget and provides at least one benefit to staff
- Some involvement of parents in the program
- A plan to address needs found in a standardized self-assessment of the program

In A Three STAR Facility you will find:

- More professional development and training hours than a STAR Two
- One half of the staff completed/enrolled in credentials or degrees
- Learning materials available for a large part of the day
- Literacy activities including reading to children, storytelling and encouraging written and verbal communication happen often during the day
- Increased parental involvement
- Written policies and procedures
- Implementation of a financial system, increased staff compensation and benefits

In A Four STAR Facility you will find:

- More professional development and training hours than STAR Three
- Two thirds of the staff completed/enrolled in credentials or degrees
- Activities designed to encourage communication, both written and verbal, occur naturally in the day
- Parental and community resources used effectively in the delivery of quality child care
- Business, organizational and staff compensation practices are maximized
- A review of the facility by a nationally recognized environmental rating scale that indicates a high quality score
- A review of the facility by a nationally recognized environmental rating scale that indicates a minimal quality score

Pennsylvania Pre-K Counts, established by the Pennsylvania Department of Education, is bringing quality half-day and full day pre-kindergarten to 11,800 3 and 4 year olds in Pennsylvania.

Why does my child need to attend a high quality pre-kindergarten program?

Quality pre-kindergarten prepares children for reading and math, but also for paying attention, following directions and getting along with others.

Pre-kindergarten gives children a chance to learn, become excited about school and be better students.

By enrolling your child in quality pre-kindergarten, your child has a better chance of being ready for kindergarten and grade school. This strong early start in pre-kindergarten means they have a better chance of doing well in school, going on to college or career training, and getting a good job.

All of this can start by enrolling your child in a PA Pre-K Counts classroom!

What can I expect from a PA Pre-K Counts classroom?

Pennsylvania *Pre-K Counts* classrooms will: have teachers with the education and expertise to teach young children; use a curriculum that will help your child grow, academically and socially; regularly review your child's progress and choose teaching and learning activities that are best for your child; help you and your child adjust to pre-kindergarten and smoothly move on to kindergarten; offer a small class size (no more than 20 students per one teacher and one aide) so that your child can have plenty of one-on-one time with the teachers.
